**Re: Notice To Cease and Desist From Murdering Haitian Migrants**

**Dear Respective Ambassadors:**

**This formal notice is now served upon you due to ongoing criminal human rights violations (National and International Human Rights Violations) being committed personally and jointly on a daily basis by your criminal President Luis Abinader and active members of his elected administration; including his police officers, and military soldiers. Be it publicly known that your joint criminal actions constitute an obvious declaration of war against the Republic of Haiti and its people. We have massive video proofs and evidence at hand.**

**If you and president Luis Abinader fail to cease and desist the above aforementioned activities including the daily harassing, defaming, beating, arresting, mass killing of the Haitian migrants living in the Dominican Republic; without further notice to you, we shall take such class criminal and civil actions as we deem obligatory to assert our people's civil and human rights. Such actions will include the willful mass killing or murder of Haitian civilians and migrants (ongoing rapes and sexual violence) as further codified under Geneva convention Commons Art. 3; Geneva convention Art. 27, Additional Protocol II Art. 4 (2). Rome Statute Arts. 7 (1) (g), 8 (2) (b) (xxii) and 8 (2) (e) (vi). Rome Statute Arts. 8 (2) (b) (ii) (iii), (v), (ix), (xxiv), 8 (2) (e) (ii)-(iv) and (xii). Geneva Convention I Arts. 19; 35-36, Geneva Convention II Arts. 22-23, 38-39, Geneva Convention IV Arts. 18, 21-22.**

**You and your government acolytes will further be charged for attacks against Haitian civilians including pregnant women (intentionally target Haitian civilian migrants) in violations of the Geneva Statutes. Rome Statute Arts. 8 (2) (b) (i) and (iv), and 8 (2) (e) (i).**

**You will further be charged for denial of Humanitarian reliefs, impedes access of humanitarian reliefs, restricts of freedom of movement of humanitarian personnel as codified under Rome Statute Art. 7 (1) (b), 8 (2) (b) (xxv).**

**You will further be charged for unlawful mass deportation, and involuntary displacements of Haitian migrants living inside the Dominican Republic in violations of Geneva Convention IV Arts. 49, 147. Additional Protocol I Art. 85, Additional Protocol II Arts. 4, and Rome Statute Arts. 7 (i) (d), 8 (2) (a) (vii), 8 (2) (b) (Viii), 8 (2) (e) (viii).**


**Further charges will be brought against you and your government for denial of Fair Trial Rights and Immigration Court Proceedings to our fellow Haitian migrants in extreme violations of Rome Statute Arts 8 (2) (a) (vi), 8 (2) (c) (iv), Commons Art. 3 of the Geneva Conventions, Geneva Convention I Art. 49, Additional Protocol I Art. 75 (4), Additional Protocol II Arts. 6 (2).**

**We expressly reserve all our equitable and vested legal rights and human remedies, including the rights to seek injunctive reliefs, the rights to seize financial assets of the Dominican Republic in foreign countries, and of course the right to recover further**

monetary and punitive damages on behalf of the Republic of Haiti and the Haitian victims of your crimes of undeclared war.

We wish to further receive your immediate assurances that your criminal government has ceased the aforementioned human and civil rights violations of the Haitian migrants living in the Dominican Republic, accompanied by expressly written proofs by June 15, 2025.

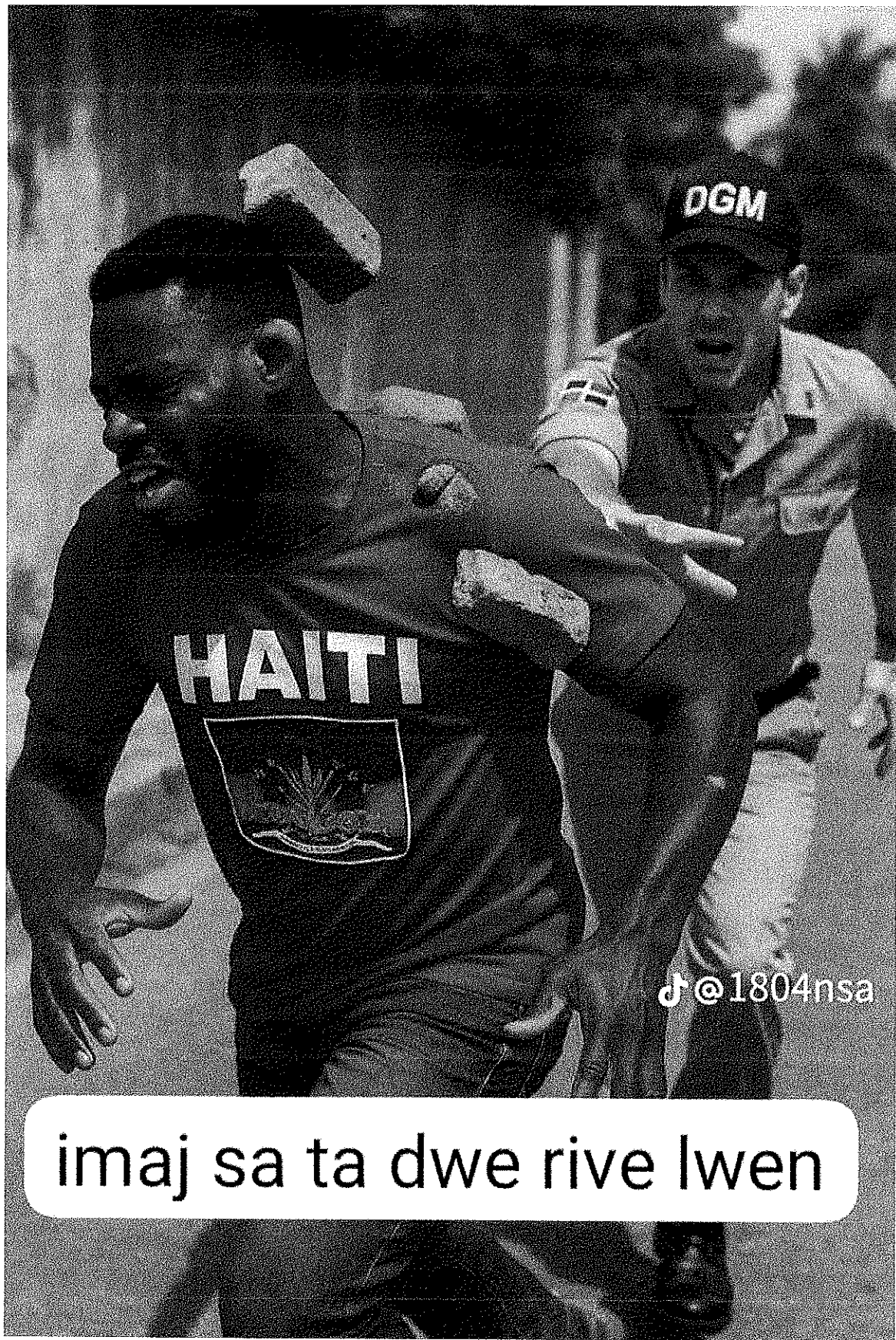
