Subject: Urgent Appeal for UN Facilitation of Transitional Governance and Security Reform in the Republic of Haiti

Dear Excellency Secretary Gutierrez:

On behalf of the Parti National de la Justice (PNDJ), I extend our appreciation to the United Nations for its continued commitment to the Haitian people and its efforts to address the protracted governance crisis and humanitarian instability in our country.

The current sociopolitical and security vacuum in Haiti—exacerbated by a decade (2015–2025) of failed leadership, institutional decay, and transnational criminal infiltration—has left the State unable to discharge its sovereign functions. Nearly all state and non-state institutions are paralyzed. The unchecked expansion of armed groups, often outnumbering or outgunning official forces, has resulted in grave violations of international humanitarian and human rights law.

We respectfully call upon the United Nations to recognize that the crisis in Haiti now constitutes a threat to international peace and security under Chapter VII of the UN Charter, and merits an urgent, coordinated international response—not only as a humanitarian matter but as a matter of international legal responsibility.

PNDJ Transitional Governance Proposal

In light of this legal and moral emergency, the PNDJ presents itself as a non-partisan, transitional governing body composed of Haitians of integrity and proven commitment to national service. We are prepared to cooperate with the United Nations and regional actors (CARICOM, AU, OAS) to restore stability, legitimacy, and constitutional order in Haiti.

Our priorities align with international best practices and include:

- Disbandment of armed militias and transnational criminal cells, with CARICOM and U.S. support
 - Transitional justice, including investigation of extrajudicial killings, organ trafficking, and illicit arms trade
 - Rule of law reforms, reestablishing judicial independence and access to justice
 - Economic sovereignty, including regulation of natural resource extraction and fiscal accountability
 - State rebuilding, through inclusive dialogue, transparency, and civil society engagement

13. Minister of Foreign Affairs – Reine Esther Erzulie Dantor
14. Minister of the Environment – Carlos Gousse
15. Minister of Public Health – Dr. Michel Ferdinand
16. Minister of Information – Reginald Miracle
17. Minister of Youth & Civic Engagement (Congress) – Dr. Kridikel Desir Truthbey

This proposed governance structure is designed to serve under a UN technical assistance framework, ensuring transparency, accountability, and alignment with international norms.

Conclusion and Request

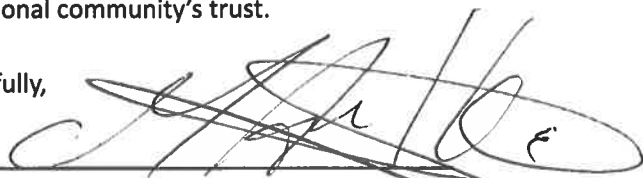
